Strategic bias in equities in free fall

US equities (1)

The Strategic Bias falls to a new alltime low for most stock markets! It is remarkable how dynamically the confidence barometer has lost value again since the March low (after the start of war in Ukraine) - although prices have recovered in the meantime. These smells of new selling pressure! What is lost at shares at confidence, is rebuilt at the U.S. bond market. Value perception is increasingly emerging here!

The S&P 500 is also struggling with gravity. While U.S. equities embody some relative strength, investors still don't trust the roast and are against U.S. equities in the medium term. The bias reaches a new 52-week low.

Background information on the sentix indices

sentix indicators are based on the sentix Global Investor Survey, a weekly survey among more than 5.000 international investors. The survey is carried out on a regular basis since February 2001. Evaluation of the indicators presented

The arrows indicate whether the indicator shown in the chart is a bullish or bearish indication for the respective market. The classification is based on a statistical examination of the indicator in relation to future price developments! The statements on the Neutrality Index refer to future volatility (fluctuation margin). The forecast horizon is 1 to 3 months.

sentix indicator	Indicator description
sentix Sentiment (short-term market expectations)	The sentix Sentiment, investors one-month expectations for a given market, reflects the emotions — between greed and fear — of market participants. Negative sentiment extremes are usually a straight indication for rising prices. High optimism may be a warning signal for an upcoming market consolidation. A sentiment divergence mostly indicates more important turning points.
sentix Strategic Bias (medium-term market expectations)	The sentix Strategic Bias, investors six-month expectations, reflects the strategic view of market participants as well as their underlying convictions and perceptions of value for a given market. As this indicator represents investors' general willingness to buy or sell it should not be interpreted as a contrarian signal. Rather it is usually leading the market by several weeks. And as the indicator mainly reflects investors' longer-term convictions and perceptions of value it is an indicator coined by the "wisdom of crowds", it bundles the knowledge floating around in a market of various players.
sentix Neutrality-Index	The sentix Neutrality Indices, represent the share of neutral investors in the market. A high percentage of such investor's points to irritation and greater volatility shortly. A low reading shows that investors have understood "the market". In the neutral camp, there is always an important part of investors who are not or only marginally invested. Those are important as they are potential future buyers or sellers! For sentix Neutrality Indices, the interpretation of the short-term and the medium-term are most of the time similar. Consequently, the case is strengthened when both time horizons reach extreme readings.
sentix Overconfidence-Index	sentix Overconfidence Index measures the probability for the case that a series of rising or falling prices has led to an augmented complacency among investors. Readings below -7 or beyond +7 are usually a sign that consolidations or corrections are imminent.
sentix Time Differential Index	For a given market, sentix Time Differential Index is calculated as the difference between the short-term sentiment and the (medium-term) perception of value. High readings of the indicator are a sign of a positive sentiment which is not supported by investors medium-term conviction, which is a stress factor for the market. In turn, low readings result when there is fear on a short-term basis but a reliable perception of value for the medium-term that is usually supportive for the market.

831 private and 253 institutional investors participated in the current survey, which was conducted from 19 to 21 August 2021.
